1. Subject

The subjects of specification are the requirements for the dietary supplement Invita Skin Beauty PLUS CoQ10 60 pcs.

2. Characteristics of the product

Invita Skin Beauty PLUS CoQ10 60 pcs is a diet supplement manufactured in accordance with the Technological Instruction T-4.1. The product is packed in white jars with white screw cap and cardboard box together with a leaflet. Invita Skin Beauty PLUS CoQ10 60 pcs is designed for the care of skin, hair, and nails.

2.1. Ingredients

Lyophilised **fish** collagen with lemon (collagen gel, lyophilised lemon in powder), algae (Fucus vesiculosus – bladderwrack), gelatin capsule (**fish** gelatin, titanium dioxide - colour), coenzyme Q10, vitamin E (D-alpha-tocopheryl acetate) from seeds of **soya**.

2.2. Percentage composition

3.2. Microbiological requirements

3.3. Individual packaging

White gelatine capsules with mass of ingredients: fish collagen with lemon powder, marine algae, vitamin E, coenzyme Q10 packed in white HDPE jars with white screw cap seal having PELD Certificate of Quality for packaging of pharmaceuticals.

3.4. Label, box, leaflet

The label made of paper, the box made of cardboard, coated with a printed foil. Leaflet made of printed paper.

4. Labelling

4.1. Label

Labelling contains:

- product name,
- capsule content,
- destination, description,
- component table,
- recommended daily consumption,
- storage conditions,
- warnings,
- the name and address of the manufacturer,
- stamps: logo, ISO,
- net weight.

4.2. Box

Labelling contains:

- product name,
- capsule content,
- storage conditions,
- recommended daily consumption,
- net weight,
- destination, description,
- component table,
- the name and address of the manufacturer,
- lot number,
- best before date: month, year.

4.3. Leaflet

Labelling contains:

- description of collagen,
- description of all products,
- product name,
- destination, description,
- component table,
- storage conditions,
- recommended daily consumption.

5. Graphic design

The graphic design of the cardboard box and the leaflet for each product is compatible with the Project.

6. Storage

Jars, labels, cardboard boxes and leaflets should be stored at the temperature of $5 - 25^{\circ}$ C and not longer than indicated on the box by the best before date. The expiry date is 24 months.
